What it is

The PM CV for Impact Trial Interviews (**Trial Interviews**) are live and interactive sessions with a PM veteran interviewer who will put you through your interviewing paces in a realistic environment.

Project management is often conducted in a very robust environment, and it's important for the PM Hiring Manager to get a feel for how the candidate performs under pressure.

Whilst we aim to make the interview as **realistic** as possible, the interviewer will be **respectful and ethical** at all times. Just like any good PM interviewer, they will probe you on your experience, your skills and your attitudes to a variety of scenarios relevant to the role, using your current CV as the main guide.

Who This Is For

This service is designed for **Project Managers, Program Managers, Agile Delivery Leads, Scrum Masters, PMO professionals**, and **other project delivery experts** who want to:

- Be at the top of their game for specific job interviews.
- Learn how to articulate their skills and experience based on their current CV
- Identify vulnerabilities and gaps in their current CV and how to compensate for them in an interview.

What we do

To deliver **Trial Interviews**, we collaborate across six (7) steps, performing one (1) cycle of information exchange by email or online chat. We hold two (2) video meetings, one to get aligned on goals and approach, and the other being the Trial Interview. We both prepare for the Trial Interview, simulating the real-life activities of the Candidate and Hiring Manager.

| 1. | Initiation | You | Complete the signup process. Our online form collects background information and payment for the service. We'll send you a receipt and an email address confirmation message. |
| 2 | Send CV, JD & Supporting Information | You | Send us your current CV plus the Job Specification or Advertisement that you want to use as the basis for the Trial Interview. We also need to identify an organisation to use for the interview. If you know the employer it's easy, but if you don't then you need to pick an organisation that is in the same industry. All documents are sent via email to support@tiligent.com |
| 3. | Goal Setting (Meeting 1) | You + Us | We will schedule a short 30-minute video meeting to confirm the goals and the approach for the next steps. |

| 4. | Research and Preparation | You + Us | We will review your CV and research the identified employer organisation You research the organisation and do any interview preparation you'd normally do. During this time, we finalise the appointment for the Trial Interview |
| 5. | Interview (Meeting 2) | You + Us | We schedule a 45-60 minute interview call at a mutually convenient time. We conduct the interview via Teams or Google Meet or equivalent. Optionally (by agreement) we'll record the meeting – this is entirely up to the client. |
| 6. | Feedback | Us | We send you written feedback on the interview, offering constructive suggestions regarding strengths and areas of improvement. We'll include a link to the recording if that was made. |
| 7. | Completion | You | Perform chosen updates on your CV and format your CV into your preferred template. |

What you Get

You get the following deliverables with the **Trial Interview Service**:

1. The completed process as defined in “What We Do” above.
2. **Interview Session** with a veteran PM Hiring Manager.
3. **Interview Feedback**, from a PM Hiring Manager perspective.
4. Optionally, a **link to the recording** of the interview.

The result is candidate awareness of interview strengths and areas for improvement.
